Role purpose

Our **International Development Department** is looking for a person who will be in charge of the development of Neoen in New-Zealand.

You will lead the development of a portfolio of wind, solar and storage power projects, with a focus on identifying the site and contracting the land, and on securing the way to market of the projects until construction starts. This role would involve the management of a team of project developers.

You will have direct responsibilities on development team from identifying the site, securing lands and permits, looking for ways to market (Corporate PPAs, tenders...), structuration of projects and until construction starts. You will manage partnerships and MnA opportunities.

Your main responsibilities will be:

Project Identification

- Identify and develop several greenfield projects, securing land lease agreements and connection rights, consultation with various local stakeholders ; controlling the development of projects in all the aspects
 - Monitoring studies
 - Coordination of all the parties involved in the projects (consultants, advisors, local authorities, grid companies, suppliers, etc.)
 - Manage the interconnection and permitting process
- Find possible partners and develop partnerships agreements to grow faster
- Review existing business opportunities through MnA, mainly on greenfield projects developed by other companies
- Define and execute Neoen's way to interact with the landowners and stakeholders in order to develop a long-term relation based on trust and local benefits

Project offtake securing

- Search PPAs or tenders opportunities to ensure a route to market for the projects
- Ensure the offtakes allow efficient structuring of the project in close link with other streams (permits, procurement, financing...) so that the project can reach construction in a timely way

Internal coordination and reporting

- Maintain and increase the project development momentum by using your natural leadership, while keeping key stakeholders involved, informed, and motivated (e.g., Neoen internal teams, partners, consultants, off-takers as well as other stakeholders involved)
- Ensure concise, clear, and decision/action-oriented reporting of development
- Share experience and ideas with the other Neoen's offices in order to facilitate growth or bridge any cultural gap

Communication and external representation

- As the local representant of Neoen in New-Zealand you will represent the company. You will interact with the different stakeholders, Governments, and industry to build long term relationship and ensure Neoen is a prime partner. You will be responsible of external communication in New-Zealand within the corporate guidelines of Neoen and in close link with the headquarter
